### **CONGREGATIONAL / CORPORATION MEETING**

The Session has called for the Annual Meeting of the Congregation on Sunday, February 1, 2026, in the Sanctuary immediately following the 11:00 a.m combined worship service (approximately 1 p.m.)

The Agenda will include the following items:
